## Want to Know What's in Your Drinking Water and Why?

### Water Quality Report provides evidence that your tap water is clean and safe to drink

With the publishing of the annual Henry County Water Quality Report on July 1, HCWA customers can have confidence knowing their tap water is clean and safe to drink. The results of this year's Water Quality Report reveal that the HCWA had no violations of drinking water quality standards – meeting or exceeding all regulatory guidelines – during the 2018 calendar year.

The purpose of the 2019 Henry County Water Quality Report is to inform consumers about what is in their drinking water and why, so they can make informed health care decisions.



The Water Quality Report includes measures of regulated substances from samples taken at the source, during drinking water production at both HCWA water treatment plants, and within the HCWA distribution system.

Potential contaminants for which regulatory agencies require testing include those categorized as organic, inorganic, or microbiological, or as the result of disinfectants or disinfectant by-products used in the drinking water treatment process.

## Teachers Observe the Water Industry from "Rain to Drain"

A dozen teachers from Henry County Schools received an up-close look at their water utility during the third annual "Rain to Drain" teacher workshops, held June 17-20.

These workshops are designed to show teachers how

the HCWA can provide them with real-world applications of the STEM curricula (Science, Technology, Engineering, and Mathematics) they teach in their respective schools.

"The Rain to Drain workshops were definitely mind-expanding and filled with useful information that will assist in helping to make real-world connections, suitable for many grade levels in multiple subject areas," says Cheryl Hinton, Fourth Grade Teacher at Oakland Elementary School.

For four consecutive days, the Henry County educators toured a different HCWA facility, while participating in activities that can translate to the classroom. Day 1 took them to the HCWA headquarters and engineering building, Day 2 featured tours of the Tussahaw Water Treatment Plant, Day 3 then moved to the Walnut Creek Wastewater Treatment Plant, while Day 4 wrapped up the workshops with a visit to the Cubihatcha Outdoor Education Center.

"I hope the teachers who participated are inspired to

engage their students in water-based learning experiences, to teach them the importance of being good stewards of our water resources, and to introduce them to the career opportunities the Water Authority offers," says Heather Toliver, Science Teacher on Special Assignment with Henry County Schools.

## Consider Upgrading Your Home with High Efficiency Toilets

**There may be financial incentives for you to do so!**

As of July 1, the HCWA has started a new year for its Toilet Rebate Program, targeting both single-family and multi-family residents of Henry County.

As a result, you may qualify for a rebate to upgrade your home with water efficient toilets, providing a financial incentive for you to practice wise water use and help us in our water conservation efforts!

By renewing its Toilet Rebate Program, the HCWA can provide credit on the water bills of customers who improve their overall household water efficiency through the installation of newer, low-flow and high-efficiency models.



For single-family residents who install new WaterSense toilets using 1.1 gallons per flush (GPF) or less, you could be eligible for a \$100 rebate. Single-family residential customers whose WaterSense labeled toilets use more than 1.1 GPF may be eligible for a \$50 rebate.

For multi-family residences that are master metered – such as apartments, townhomes and condos – those property owners may qualify for a \$50 rebate for installation of a high efficiency toilet, or a \$75 rebate for installation of an ultra-high-efficiency toilet.

Requirements include homes or properties built in or prior to 1993. You also must have a receipt of your new toilet purchase, and there is a limit of two toilets per property.

Since toilet rebate programs in metro Atlanta began in 2008 as an initiative of the Metropolitan North Georgia Water Planning District, over 135,000 old, inefficient toilets have been replaced with low-flow and high-efficiency models, resulting in a savings of 2.4 million gallons of water a day.

## Don't Forget to Vote on Nov. 5th!

### A public service announcement from Henry County

Henry County Government is reminding residents that there may have been a change in your local polling place. To check your voter registration status, your polling place, and to print out a precinct card and sample ballot, please check online at [www.mvp.sos.ga.gov](http://www.mvp.sos.ga.gov).

On Nov. 5, 2019, there will be a county-wide SPLOST vote held at the same time as the city elections. To check to see if you are registered within the city limits and to verify if you are eligible to vote in the city election, again visit [www.mvp.sos.ga.gov](http://www.mvp.sos.ga.gov) to check to see if you have a city polling place listed.

If you vote during early voting for this November's election, you'll be able to vote in both the city and county elections at the same location. If you wait until Election Day to vote, you will be required to visit both your local and the city polling locations.
